

By-Law 574

TOWN OF MILK RIVER

A By-Law to authorize the Municipal Council of the Town of Milk River, in the Province of Alberta, to enter into agreements with Her Majesty The Queen in the right of Alberta (Represented by the Minister of the Environment).

WHEREAS under the provisions of Section 116 of the Municipal Government Act, being Chapter M-26 of the Revised Statutes of Alberta, 1980, (as amended), the Council may pass a By-Law authorizing the making of an agreement with the Province of Alberta, or its agents, for the performance of any matter or thing considered by the Council and the Province or its agents to be a benefit to both parties; and

WHEREAS under Section 7 of the Land Surface Conservation and Reclamation Act Act the Minister of the Environment may enter into an agreement with an owner to restrict the use of certain land;

NOW THEREFORE the Municipal Council of the Town of Milk River in Council assembled enacts as follows:--

That the Mayor and the Administrator of the Town of Milk River be and are hereby empowered to execute an agreement similar to the form attached marked Exhibit "A", between the said Town and the Minister of the Environment relating to reclamation of certain lands described as follows:--

THE NORTH EAST QUARTER OF SECTION TWENTY EIGHT (28)
TOWNSHIP TWO (2)
RANGE SIXTEEN (16)
WEST OF THE FOURTH MERIDIAN
CONTAINING 64.7 HECTARES (160 ACRES) MORE OR LESS
